The binder is monomer vinyl acetate and ethylene classified BfR XIV and FDA 176.170, in which has been added inert mineral fillers. This quality doesn't contain : optical brightness, dangerous substance for the environment (classified N in Annex 1 of EU Directive 67/548/EEC and its amendments) at concentrations greater than 0,1% by weight in the formulation. Concerning the correspondence with regard to the Guide of the good practices for the manufacturing of papers and cardboards intended for food contact, our supplier can guarantee that being ISO certified 9001:2000 (Quality) since 2002, ISO 14001 (Environment) since 1997 and OHSAS 18001 (Safety) since 2005, our supplier make sure of the selection and the control of raw materials, as well as the manufacturing processes. Further to this, the quality can perfectly be considered as adapted to food contact..
